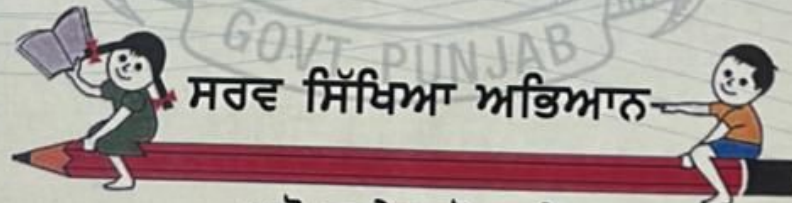

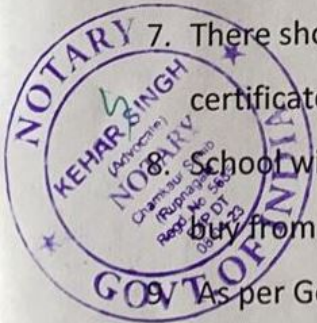

Rules to be followed under RTE act 2009 are given below:-

1. School should be running by register society/trust/institution
2. School building should be safe and should not be used for other purpose except education.
3. In school in primary class teacher student ratio should be 1:30 and upper primary ratio should be 1:35.
4. According to the strength there should be proper arrangement of portable water, toilets and their cleanliness.
5. School should have play ground.
6. Teacher should be qualified and they should be paid salaries according to government graded [basic pay] pay should be deposited in their bank accounts.
7. There should be proper fire safety equipment and school must have fire safety certificate.
8. School will not sell books/notebooks/stationery/uniforms etc. or shall not force to buy from specific shop.
9. As per Govt. instructions 25% also reserved for the students below poverty line.
10. There should be register to vassals the students regularly.
11. School account should be scrutinized by a registered agency every year.
12. Students should not be given any corporal punishment.
13. School teachers cannot take tuition.

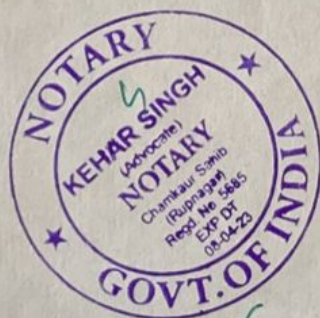
